INFORMATION NOTE: Pursuant to an Ordinance adopted January 12, 1983;

- Section 7 Article B - The licensee shall provide one (1) off street parking space for every two hundred (200) square feet of floor area.
- Section 11 Article A - No devices subject to this Ordinance may be operated within five hundred (500) feet of a school. or house of worship.
- Section 11 Article B - No premises shall be issued licenses for a device if such premises are located in the following zones as referenced in the Town of Kearny Zoning Ordinance: R-1, R-2, R-3 and R-2A.
