The New Jersey Uniform Construction Code N.J.A.C. Chapter 23, Title 5 requires the holder of a permit to notify the Construction Official or appropriate Subcode Official when the work is ready for any required inspection specified herein. - This notice shall be given at least 24 hours prior to the time the inspection is desired. Inspections shall be performed within three business days of the time for which it was requested. The work shall not proceed in a manner which will preclude the inspection until it has been made. The conditions of a permit shall include but not be limited to the following:

- 1) Post a true copy of the permit at a conspicuous location at the job site.
- 2) ***Keep the approved plans and specifications at the building site as per NJAC 5:23-2.16 e.***
- 3) 24 hour notice to the Construction Official prior to the start of work.
- 4) Obtain the following inspections during the progress of work:

Building Inspector - Bob Charles - 201-955-7880 ext. 3007 - Inspections: Monday thru Friday

(8 am to 4 pm)

- 1) The bottoms of all footing trenches prior to pouring concrete.
- 2) The formation of pile caps, reinforced walls, grade beams and floors prior to pouring concrete.
- 3) Foundations and all walls up to grade level prior to back fill.
- 4) All structural framing and connections prior to covering with finish or insulation.
- 5) Platform - Roofs - Siding - Fences - Pools - Signs - etc.
- 6) Final inspection at completion of work.
