5-34.3 Fee.

a. Upon filing such application, the applicant shall pay to the Construction Code Department a fee of one hundred (\$100.00) dollars for such license or for relicensing after revocation of a license previously issued to such applicant in accordance with the provisions of subsection 5-34.11 hereof; provided, however, that if the applicant demonstrates that he or she does not employ, at any time, more than one person, the fee shall be fifty (\$50.00) dollars.

b. The term of such license shall expire on December 31 of the calendar year in which such license is issued except in the case of licenses issued in calendar year 2003, in which case such licenses shall expire on December 31, 2004.

c. Such license shall be renewed by the Construction Official upon payment by the applicant of an annual renewal fee of fifty (\$50.00) dollars except in the case of an applicant who demonstrates that he or she does not employ, at any time, more than one (1) person, in which case the annual renewal fee shall be thirty (\$30.00) dollars. The licensee must make an application for renewal not earlier than ninety (90) days before the commencement of the calendar year for which such renewal is sought and not later than the commencement of the calendar year for which such renewal is sought. Upon failure to renew any license on or before March 31 of the immediately succeeding calendar year, any subsequent license shall be construed to be a new or original license, subject to the filing of a new application in accordance with the provisions of subsection 5-34.2 hereof and to the payment of the fee specified in subsection 5-34.3a.

5-34.4 Standards.
